# Japan's Healthy Profit

The medical and pharmaceuticals industries have always been vital to the economy.

There is no more important field for innovation and enterprise than healthcare. In Japan, the sector has a proud tradition of success that benefits society, and the economy in general, through development of medicines, equipment and systems. According to leaders within the industry, this impact can be attributed to a combination of traditional Japanese business standards and cutting-edge research and development (R&D). Sohta Yamaguchi, president of ASKA Pharmaceutical Co., Ltd., admitted the industry faces stiff competition from overseas. "We are seeking new ways to maintain our edge in the field by trying new, out-of-thebox ideas and leveraging the unique demographic situation in Japan,"said Yamaguchi. Tadashi Imamura, managing director of MIZUHO MEDY Co., Ltd., agreed. "Innovation is absolutely necessary when working in fields where human lives are at stake," said Imamura. The aging population and shrinking workforce are issues the health industry takes very seriously, as does Noriyuki Matsunaga, president of Matsunaga Manufactory Co., Ltd. "One issue for the future is the shortage of care workers. Creating more sophisticated wheelchairs that allow the elderly to do more by themselves is the goal," said Matsunaga. A further delicate challenge facing R&D is introducing robotics to support medical testing. "We have already initiated collaborations with pharmaceutical companies to develop automated inspection solutions," said Keiji Katano, the president of Icomes Lab Co., Ltd.
